AIIMS Guwahati invites applications for the following contractual positions for the project entitled “National Mental Health Survey in India 2” funded by Ministry of Health and Family Welfare, Government of India and coordinated by NIMHANS, Bangalore in the state of ASSAM under **Dr. Forhad Akhtar Zaman** (Main-Principal Investigator, Department of Community and Family Medicine), and **Dr Ramdas Ransing** (Principal Investigator, Department of Psychiatry). The NMHS-2 (Assam) is a household level survey to be conducted in **Sribhumi, Darrang, Barpeta, Dibrugarh, Kamrup-Metro or other districts of Assam** as per the requirement of project.

Specific responsibilities	1. Plan field data collection activities and coordinate with local authorities. 2. Conduct field data collection as per the approved plan. 3. Ensure regular daily data backup. 4. Prepare daily and weekly reports and maintain records in the prescribed formats.
Nature of work	Candidates must be willing to travel extensively to survey districts, Monitor the progress of the survey, supervise field activities and liaison with local coordinators. Candidates should have the experience of administering psychiatric survey instruments
Maximum Age Limit	40 / 45 years
Duration	Initial appointment will be for 2 months and extended further depending upon the performance of the candidate.

Note: 1) The candidate must be willing to undertake other responsibilities as assigned by PI or Co-PI, 2) The job requires field visits to villages or urban areas located in the above-mentioned districts of Assam, 3) The number of advertised seats may be increased or decreased as per project requirements during the recruitment process.

- Candidates should bring two photocopies of application form and supporting document along with original documents for verification at the time of interview.
- The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
- Result will be published on AIIMS Guwahati Website after the selection process is over.

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she doesn't fulfill essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Guwahati or NIMHANS or MOHFW.
3. Tenure: The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or NIMHANS or MOHFW or for continued contractual appointment.
4. Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. Accommodation: No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of interview.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted with the application form. Failing these, he/she will not be allowed to participate in the walk-in-written test or interview.
9. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.
10. No travelling or other allowances will be paid to the candidate for appearing in written examination or for joining the post.
11. Canvassing of any kind will lead to disqualification.
12. Private practice of any type is prohibited.
