#### Training Program: Interventional and Implementation Research in Mental Health and Neurosciences

AIIMS Guwahati invites applications from early-career researchers working in the field of mental health and neurosciences for a training program on Interventional and Implementation Research in Mental Health and Neurosciences sanctioned to Dr. Ramdas Ransing, Program Coordinator/Principal Investigator, Associate Professor (Psychiatry), AIIMS Guwahati. The training program is funded by the Department of Health Research (DHR) - Indian Council of Medical Research (ICMR), Ministry of Health and Family Welfare (MOHFW), New Delhi, Government of India.

#### **Brief Details of Training Program:**

Recent government reports and scholarly publications have consistently emphasized the need to empower mental health researchers in the Northeastern states (Arunachal Pradesh, Assam, Manipur, Mizoram, Tripura, Meghalaya, Nagaland, Sikkim) through structured training and mentoring. Developing and implementing evidence-based interventions that are locally adapted, culturally and linguistically appropriate, and aligned with national and international standards has potential to improve the mental health care in the north east region. Through this training program, Department of Psychiatry-AIIMS Guwahati, in collaboration with other departments of institute, regional/national academic and research institutes, state governments, and national and international institutes/researchers, aims to mentor and support early-career researchers in psychiatry, mental health, and neurosciences of all northeastern states.

# Why AIIMS Guwahati for this training?

Department of Psychiatry, AIIMS Guwahati provides a unique platform for observation, learning, and hands-on training through its ongoing research projects focused on the specific mental health need of north-eastern states. Department of Psychiatry, in collaboration with other departments of AIIMS Guwahati, and national and international institutes, is actively engaged in or planning for funded research projects. These projects encompass areas such as Digital / Technology based interventions, Consultation-Liaison Psychiatry, Student Mental Health and Wellbeing, Suicide Prevention, Tobacco Cessation, Addiction, Child and Adolescent Psychiatry, Neurocognitive Disorders, Biomarkers, EEG, Neuroimaging, Brain Stimulation, Non-Communicable Diseases (NCDs), and Common Mental Disorders, psychiatric epidemiology, and rehabilitations. We believe that the ongoing research projects at AIIMS Guwahati, along with interactions with the research team, staff, students, and faculty, as well as mentorship from experienced experts, will provide valuable support for early-career researchers in identifying key challenges, overcoming barriers, and developing innovative solutions to improve psychiatry/mental health care in the North- East states.

### **Research Area for Training Program:**

Interventional and implementation research on the psychiatric disorders enlisted above, addressing pharmacological and/or non-pharmacological interventions (such as brain stimulation procedures), technology-based approaches, treatment gap reduction, prevention and mental health promotion, disability and the rights of individuals with mental illness, as well as the social, psychological, and legal dimensions of mental health and illness.

**Mode of training:** Hybrid (Virtual + Physical)

**Duration of Training:** 12 months (including 2-4 weeks on-site training at AIIMS Guwahati or Collaborating Institute for training in the respective north-east state).

Course Fee: There is no course fee for enrolling in the program, and no travel or accommodation costs for

participating in the on-site training (For participants from North-East State).

Course Faculty: Faculty from Department of Psychiatry, Clinical Neurosciences, Addiction Medicine, and

other departments of AIIMS Guwahati, along with faculty from collaborating institutes, government

organizations, and national and international invited experts.

Certifications: A course certificate will be issued upon successful completion of assignments and exams

conducted at AIIMS Guwahati or the collaborating institute in the respective state, at periodic intervals and at

the end of the 12-month training period.

**SELECTION PROCESS:** 

1. Interested candidates who meet the course criteria may submit their application (in the prescribed

format) along with copies of their Curriculum Vitae, qualifications, experience, and letter of

permission by email to psychiatry@aiimsguwahati.ac.in and send hard copies to address mentioned in

application form on or before 20th February 2025.

3. Any application received after 20th February 2025 will not be considered.
