The candidature of all the candidates for personal interview is purely provisional and subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, experience, reservation, etc. and if they are found ineligible at any stage, their candidature will be cancelled.
- 5. Candidates are required to appear for the interview physically and must bring all original documents in support of their eligibility for the post applied for as well as other documents requested as per the Advertisement and eligibility lists.
- 6. The candidates will have to produce the original documents at the time of joining, failing which, their candidature will be cancelled.
