- 3) No representation(s) without supporting documents will be entertained.
- 4) Depending on the number of applicants reporting on the day of the interview, a written examination (MCQs from topics such as basic laboratory techniques, molecular cell biology, instrumentation, research methodology, basic computer application, and basic English) may be conducted to shortlist candidates for the interview. The written examination will be held at the Medical College building, AIIMS Guwahati, and both the written examination and interview will be conducted in physical mode only on 26.12.2025.
- 5) The candidates shortlisted for the written examination/interview must bring all ORIGINAL documents (along with one set of photocopies) in support of their eligibility, as well as other required documents as per the advertisement.
- 6) The candidature of all the candidates for the written examination/personal interview is purely provisional, subject to verification and fulfilment of the eligibility criteria with regard to age, essential qualification, and experience, etc and if they are found ineligible at any stage, their candidature will be cancelled.
- 7) The letter of appointment will be offered by ICMR-NIRDHDS, New Delhi, directly, and AIIMS Guwahati will only recommend the selected candidate's name to the funding agency. The candidate has to follow the rules of service of the funding agency or outsourced agency nominated by ICMR-NIRDHDS and AIIMS Guwahati.
