DOCUMENT VERIFICATION:

- The candidates will be called for document verification/interview as per the order of merit.

 - Educational and experience certificates;
 - Valid registered Nurse/Midwife registration certificate in State Nursing Council and renewal certificate (if applicable).
 - Original Caste, EWS, and PwBD Certificate, if applicable.
 - Candidates belonging to the OBC (non-creamy) category should produce a certificate from the Competent Authority showing a validity period in accordance with Govt. of India guidelines. The certificate should be for the **current financial year**.
 - Those candidates, who are in Government/Semi-Government/PSUs/Autonomous Bodies or otherwise (including AIIMS Employees) are required to produce a **No Objection Certificate (NOC)** at the time of the interview. No candidates will be allowed to appear for the document verification/interview without proper NOC as per the conditions of the advertisement.
 - You are required to send a **PowerPoint Presentation** (Black & White, Font – Calibri size 24) - Please share the PPT in the prescribed format (**Annexure III**) to Recruitment Cell, AIIMS, Guwahati i.e., recruitment-cell@aiimsguwahati.ac.in before **28.11.2025** positively. The candidates are also advised to bring the PPT in a pen drive on the day of the document verification/interview.

Important Note:

1. The provisional inclusion of the candidates for the document verification process does NOT indicate that his/her candidature will be considered for the next stage of the interview.
2. Applicants who do not meet the requisite qualifications/experience as per the advertisement will not be considered for the personal interview.
