- 4. Application should be mailed to above email IDs within 15 days of the publication of this advertisement on the AIIMS Guwahati website (<a href="https://www.aiimsguwahati.ac.in">https://www.aiimsguwahati.ac.in</a>) i.e. on or before 16.12.2025.

- 5. List of shortlisted candidates will be published on AIIMS Guwahati website before the interview. Any information/update regarding this advertisement including interview dates will be published on the official website of AIIMS Guwahati only in due course. Candidates are advised to visit the website regularly for updated information in this regard.
- 6. The interview will be conducted through offline mode only.
- 7. Place of Interview: AIIMS Guwahati
- 8. Candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
- 9. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
- 10. Result will be published on AIIMS Guwahati website after the selection process is over.

#### Terms and conditions

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process, the candidate may be rendered disqualified at the time of document verification if he / she doesn't fulfil essential eligibility criteria.
- 2. Age relaxation is admissible as per Govt of India guidelines.
- 3. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Guwahati.
- 4. **Tenure:** The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.
- 5. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
- 6. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
- 7. The candidate already in government service shall submit 'No Objection Certificate' from the present employer at the time of interview.
- 8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview. The Department may have specific requirement on the eligibility of candidates which will be adopted during the selection process. Depending on the number of applications received, desirable qualification may be used for the purpose of shortlisting of candidates. A written examination may also be conducted to shortlist the candidates for the interview. In such a scenario, the venue of the written examination will be AIIMS Guwahati.
- 9. One set of self-attested photocopies of the relevant documents would need to be emailed with the application form. The list of documents to be emailed is provided at the end of application form (check-list). In addition, candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
- 10. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.
- 11. No travelling or other allowances will be paid to the candidate for appearing in written examination/Interview or for joining the post.
- 12. Canvassing of any kind will lead to disqualification.
- 13. This is a full-time position under funded project. Involvement of the candidate in any other job simultaneously is prohibited.

- 14. The candidate is expected to conform to the rules of conduct and discipline as applicable to the Institute employees.
