The above candidates are requested to produce the following documents in original along with one set of photocopies before the constituted committee failing which the candidature of the candidate may be rejected:

1. Printout of online application form.
2. Provisional seat allotment letter issued by AIIMS, New Delhi.
3. Admit card of the CRE exam conducted by AIIMS, New Delhi.
4. Certificate for the proof of Date of Birth (10<sup>th</sup> or 12<sup>th</sup> certificate/marksheet/birth certificate).
5. Mark sheets and pass certificate (final/ provisional) of all examinations passed (10<sup>th</sup> grade, 12<sup>th</sup> grade, graduation/others etc) including the highest/specialised qualification attained for the selected post.
6. Essential experience certificate required for the post, if any.
7. Proficiency in computer application required for the post, if any.
8. Category certificate for those belonging to OBC-NCL, SC, ST, EWS, PWBD or Ex-Serviceman. The valid OBC-NCL certificate issued during the period from 01.04.2024 to 31.01.2025 will be considered. EWS certificate issued in prescribed format for employment in Central Government on the basis of income for the financial year 2023-2024 issued from 01.04.2024 but not later than 31.01.2025 will be considered.

9. Marriage certificate, if applicable.

10. No Objection Certificate (NOC) from the Competent authority as applicable.

11. Original ID card for proof of identity issued by any government authority (Aadhar/Passport/Voter ID).

12. Address proof issued by any government authority (Electricity Bill, Ration Card, Voter Card, Passport, Aadhar etc).

Offer of appointments will be issued by AIIMS, Guwahati (physical/ over email) to all the candidates whose document verification process would be done successfully. However, offer of appointment will be purely provisional and subject to the outcome of various cases if any pending before Hon'ble Court/High Court etc.

AIIMS, Guwahati will not bear any expense related to the transportation or else while the candidates are arriving for document verification. Candidates are requested to extend cooperation to the document verification Committee of AIIMS, Guwahati.
