- 4. Application should be mailed to above email IDs within 15 days of the publication of this advertisement on the AIIMS Guwahati website (<u>https://www.aiimsguwahati.ac.in</u>) i.e. on or before **17.04.2025**.
- 5. List of shortlisted candidates will be published on AIIMS Guwahati website before the interview. Any information/update regarding this advertisement including interview dates will be published on the official website of AIIMS Guwahati only in due course. Candidates are advised to visit the website regularly for updated information in this regard.
- 6. The posts are being advertised in accordance with the broad subject area of the sanctioned research project and the general eligibility criteria for applicants. The Department concerned may have specific requirements regarding the qualifications and experience of candidates, which will be considered during the shortlisting process.
- 7. The interview will be conducted through offline mode only.
- 8. Place of Interview: AIIMS Guwahati
- 9. Candidates are required to bring one copy of application form and supporting documents (selfattested) as provided under checklist along with original documents for verification at the time of interview.
- 10. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
- 11. Result will be published on AIIMS Guwahati website after the selection process is over.

Terms and conditions

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. - 3. **Tenure:** The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.

- 4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
- 5. Accommodation: No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
- 6. The candidate already in government service shall submit 'No Objection Certificate' from the present employer at the time of interview.
- 7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection. The Department may have specific requirement on the eligibility of candidates which will be adopted during the selection process.
