Applications are invited for the position of **Project Research Scientist-I (Non-Medical)** under the Indian Council of Medical Research (ICMR) funded Extramural Research Project titled: **“Identification of the Clinical Phenotypes and Comparison of Risk Factors of Thiamine Deficiency-Related Disorders in Various Regions of India: A Multicentric Study”** The position is **purely on contractual basis** under the Principal Investigator: **Dr. Bhupen Barman**, Professor and HOD, Department of General Medicine, AIIMS Guwahati.

Note

1. All educational qualifications/certificates should be from a Recognized Board/University.
2. All experience gained shall preferably be from Government Organisations and shall be counted only after the date of completion of the Minimum Essential Qualification. Experience from reputed National/International Organizations shall also be considered.
3. Experience shall be from the relevant field/area, as required for the study of the concerned Project.
4. Selected candidates will be initially appointed for a six-month period, with the possibility of extension for the duration of the project based on satisfactory performance reviews conducted every six months.

5. The candidate must be willing to undertake other responsibilities as may be assigned by the Principal Investigator (PI) from time to time.

Indicative Roles and Responsibilities

- Manage daily operations of the research project.
- Supervise staff involved in intervention delivery, data entry, and data management.
- Oversee data collection staff and study participant follow-up.
- Coordinate intervention components with the PI and field staff.
- Conduct project staff meetings and maintain quality control measures.
- Prepare regular project reports for ICMR.
- Oversee project budget and accounting.
- Coordinate with the institution's technical and administrative units and with ICMR.

Selection Process

2. No separate email submission is required. **Submission through the Google Form is sufficient.**
3. The **last date for submission** of the Google Form is **7 days from the date of advertisement**. Applications submitted after 7 days will **not be considered**.
4. Candidates must upload **scanned copies** of all required documents.
5. Shortlisted candidates must bring **original certificates** and **two photocopies** for verification at the time of the interview.
6. The **list of shortlisted candidates** will be published on the **AIIMS Guwahati website**.
7. **Only shortlisted candidates** will be called for the interview.
8. **Date of Interview will be intimated later.**
9. Interview Mode: **Offline only**
10. **Place of Interview:** AIIMS Guwahati
11. Any **misrepresentation** or incorrect details in the application will lead to **disqualification**.
12. The **decision of the Selection Committee**, subject to approval by the Executive Director, AIIMS Guwahati, will be **final**.
13. The **result** will be published on the **AIIMS Guwahati website**.
14. **Selected candidates must join immediately** upon selection.

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfil essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Guwahati.
3. Tenure: The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.
4. Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. Accommodation: No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of interview.

7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted at the time of interview/written test. Failing these, he/she will not be allowed to participate in the interview/written test.
9. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.
10. No travelling or other allowances will be paid to the candidate for appearing in the interview/written test or for joining the post.
