- 3) Class 12<sup>th</sup> certificate and mark sheet.
- 4) Degree certificate (B.Sc./M.Sc.) or Diploma in General Nursing Midwifery.
- 5) Registration certificate as Grade "A" Nurse or Midwife from State/Indian Nursing Council.
- 6) Experience certificate.
- 7) NOC, if applicable.
- 8) Caste certificate (OBC-NCL/SC/ST), if applicable.
- 9) EWS certificate, if applicable.
- 10) PWBD certificate, if applicable.
- 11) Registration slip of online registration having candidate's signature.
- 12) Admit card having candidate signature.
- 13) Copy of original ID card for proof of Identity issued from any Government Authority/Aadhar Card/Passport.
- 14) Copy of address proof issued by any Government authority like Electricity bill, Ration card, Voter card etc.
