- 5. Candidates should bring two photocopies of application form and supporting document along with original documents for verification at the time of interview.
- 6. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
- 7. Result will be published on AIIMS Guwahati Website after the selection process is over.

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience.
