- 7. Only shortlisted candidates will be called for the interview
- 8. Date of Interview: Third week of October' 2023 (Exact date will be intimated later)
- 9. The interview will be conducted through offline mode only
- 10. Place of Interview: AIIMS Guwahati
- 11. The shortlisted candidates should bring two photocopies of application form and supporting document along with original documents for verification at the time of interview.
- 12. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
- 13. Result will be published on AIIMS Guwahati Website after the selection process is over.

TERMS & CONDITIONS

- 8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 9. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted with the application form. Failing these, he/she will not be allowed to participate in the walk-in-written test or interview.
