3. The candidates are required to produce No Objection Certificate (NOC) signed by the Competent Authority of their respective organization and not by the candidate himself if happened to be the Issuing Authority at time of interview. No candidate will be allowed to appear for the interview without NOC.
4. Those candidates who want to appear for interview must bring all original documents in support of their eligibility for the post applied for as well as other documents requested as per the Advertisement No. 2-378/2023-24/AIIMS/GHY/ESTT./DEPUTATION / 996 dated 09/20-07-2024.
5. The candidates will have to produce the original documents at the time of joining, failing which, their candidature will be cancelled.
6. The date and time for the interview along with necessary instructions will be uploaded on Institute's website i.e., <https://www.aiimguwahati.ac.in/> in due course of time and call letters for interview will be issued to all the eligible candidates in due course.
