Advertisement for the post of Project Associate I

Online applications (through email) are invited from eligible candidates for the post of **Project Associate I**, purely on **contractual basis** in the extramural research project titled '**Assessment of Clonal Hematopoiesis of Indeterminate Potential (CHIP) as a Risk Factor of Premature Atherosclerotic Cardiovascular Disease (Premature-ASCVD)**', sanctioned for up to 3 years from Department of Biotechnology, Ministry of Science and Technology, Government of India (No. BT/PR67402/CMD/150/216/2026, dated 10.09.2026), under Dr. Ashikh A Seethy, Associate Professor, Department of Biochemistry, AIIMS Guwahati. 2. The filled-up application form along with required documents should be emailed to biochemistry@aiimsguwahati.ac.in. The list of documents to be emailed is provided at the end of application form (check-list). All documents must be emailed as a single PDF file.
3. The subject of the e-mail should be mentioned as "Name of the Applicant – Biochemistry – Project Associate I – DBT – Premature ASCVD and Clonal Hematopoiesis".

4. Application should be mailed to the email ID (biochemistry@aiimsguwahati.ac.in) **within 15 days** of the publication of this advertisement on the AIIMS Guwahati website (<https://www.aiimsguwahati.ac.in>) i.e., on or before **October 08, 2026**.
5. Applications received after the cut-off date will be summarily rejected.
6. List of shortlisted candidates will be published on AIIMS Guwahati website before the interview. Any information/update regarding this advertisement including interview dates will be published on the official website of AIIMS Guwahati **only** in due course. Candidates are advised to visit the website regularly for updated information in this regard.
7. No individual intimation will be sent by AIIMS Guwahati to the applicants. Candidates are hence requested to follow up recruitment notices on the website periodically.
8. The Principal Investigator/AIIMS Guwahati reserves the right to conduct a screening/skill test to shortlist candidates for the interview, depending on the number of applications received and the level of competition. In such a scenario, the venue of the screening/skill test will be AIIMS Guwahati. No travelling or other allowances will be paid to the candidates for appearing in the screening/skill test. The Principal Investigator/AIIMS Guwahati also reserves the right to shortlist the candidates based on the desirable qualification, depending on the number of applications received.
9. The posts are being advertised in accordance with the broad subject area of the sanctioned research project and the general eligibility criteria for applicants. **The Department concerned may have specific requirements regarding the qualifications and experience of candidates, which will be considered during the shortlisting process.**
10. The interview will be conducted through offline mode only.
11. Place of Interview: AIIMS Guwahati
12. Candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
13. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
14. Result will be published on AIIMS Guwahati website after the selection process is over.

Terms and conditions

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process, the candidate may be rendered disqualified at the time of document verification if he / she doesn't fulfil essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Guwahati.
3. **Tenure:** The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.
4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. **Accommodation:** No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate already in government service shall submit '**No Objection Certificate**' from the present employer at the time of interview.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview. The Department may have specific requirement on the eligibility of candidates which will be adopted during the selection process. **Depending on the number of applications received, desirable qualification may be used for the purpose of**

shortlisting of candidates. A written examination may also be conducted to shortlist the candidates for the interview. In such a scenario, the venue of the written examination will be AIIMS Guwahati.

8. Age relaxation is admissible as per Govt of India guidelines.
9. One set of self-attested photocopies of the relevant documents would need to be emailed with the application form. The list of documents to be emailed is provided at the end of application form (check-list). In addition, candidates are required to bring one copy of application form and supporting documents (self-attested) as provided under checklist along with original documents for verification at the time of interview.
10. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.
11. No travelling or other allowances will be paid to the candidate for appearing in written examination/Interview or for joining the post.
12. Canvassing of any kind will lead to disqualification.
13. This is a full-time position under funded research project. Involvement of the candidate in any other job simultaneously is prohibited.
14. The candidate is expected to conform to the rules of conduct and discipline as applicable to the Institute employees.

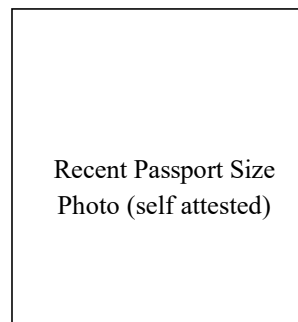
