- b) Original Caste, EWS and PwBD Certificate, if applicable.
- c) Candidates belonging to the **OBC** (**non-creamy**) category should produce a certificate from the Competent Authority showing a validity period in accordance with Govt. of India guidelines. The certificate should be for the current financial year.
- d) **PowerPoint Presentation** Please share in the PPT prescribed format (will be sent along with email) to Recruitment Cell, AIIMS, Guwahati i.e., <u>faculty-recruitment@aiimsguwahati.ac.in</u> on or before **25.10.2025** positively.
- e) "No Objection Certificate" from the Competent Authority, if applicable.

## Important Note:

- 1. The candidates shortlisted for the Interview must bring all ORIGINAL documents in support of their eligibility for the verification.
- 2. Those candidates, who are in Government/Semi-Government/PSUs/Autonomous Bodies or otherwise (including AIIMS Employees) are required to produce a **No Objection Certificate (NOC)** at the time of the Interview. No candidates will be allowed to appear for the Interview without proper NOC as per the conditions of the advertisement.
- 3. Candidates applying for the posts reserved for OBC must produce a **certificate of OBC (non-creamy layer) of the current financial year in the prescribed form issued by the Competent Authority** at the time of document verification, failing which the candidate will not be allowed to appear for the interview.

- 4. The candidature of all the candidates shortlisted for the Interview is purely provisional and subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, experience, reservation, etc. and if they are found ineligible at any stage, their candidature will be cancelled.
- 5. The eligible/provisionally eligible list as notified is purely tentative and may vary (both inclusion/exclusion) subsequently after detailed document verification. The decision of the Competent Authority in this regard will be final.
- 6. No TA/DA shall be provided for this purpose.
