- b) Quotations must be in the enclosed prescribed Performa (*Annexure –A*) forwarded on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative. In case of signing of quotation by the authorized representative, letter of authorization must be attached with the quotation.
- c) The work shall be executed as per direction of the Engineer.
- d) Rates must be inclusive of all charges (including Freight charges, all taxes etc.).
- e) No overwriting is permitted in the rate. If found, the quotation shall be summarily rejected.
