- Coordinate intervention components with PI and field staff
- Conduct project staff meetings and maintain quality control measures
- Prepare regular project reports for ICMR
- Oversee project budget and accounting
- Coordinate with the institution's technical and administrative units, and the ICMR.

#### 2. Project Technical Support-III

- Coordination of activities at the level of health facilities
- Administer study tools, conduct qualitative interviews along with Project Research Scientists
- Tracking and follow-up of patients
- Data entry and reporting
- Participation in regular team meetings to improve implementation of model
- Project supply purchases and indenting, maintenance of equipment.

7. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
8. Details of selection will be communicated only to selected candidates and selection list will be published on AIIMS Guwahati website after the selection process is over.
9. Selected candidates must be willing to join immediately upon selection.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfill essential eligibility criteria.

3. Tenure: The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.
4. Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. Accommodation: No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of interview.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted at the time of interview/written test. Failing these, he/she will not be allowed to participate in the interview/written test.
