This is in reference to the Advertisement Notice No. 355/2025 dated 11/11/2025 and Corrigendum No. 46/2025 dated 20.11.2025 published by AIIMS, New Delhi, for the Common Recruitment Examination (CRE)-4 for recruitment to various Group B & C posts on Direct Recruitment basis at AIIMS Guwahati & other Central Government institutes/bodies.

2. CBT Examination for the above-mentioned posts was conducted on 22<sup>nd</sup>, 23<sup>rd</sup>, 24<sup>th</sup> December 2025 in various cities across the country. Skill test for the above-mentioned post was conducted on 12.02.2026, 28.02.2026 & 01.03.2026.

Consequent upon the declaration of results of Common Recruitment Examination (CRE)- 4 conducted by AIIMS, New Delhi, vide Result Notification 157/2026, 158/2026 Dated 06.05.2026; the following provisionally selected candidates for various category of posts for AIIMS, Guwahati are hereby requested to appear before the Document Verification Committee of AIIMS Guwahati constituted for the said purpose **on 10.06.2026 during office hours.**

5. The above candidates are requested to produce the following documents in original along with one set of photocopies before the constituted committee failing which the candidature of the candidate may be rejected:

- Printout of online application form.
- Provisional seat allotment letter issued by AIIMS, New Delhi.
- Admit card of the CRE exam conducted by AIIMS, New Delhi.

- iv. Certificate for the proof of Date of Birth (10<sup>th</sup> or 12<sup>th</sup> certificate/marksheet/birth certificate).
- v. Marksheets and pass certificate (final/ provisional) of all examinations passed (10<sup>th</sup> grade, 12<sup>th</sup> grade, graduation/others etc) including the highest/specialised qualification attained for the selected post.
- vi. Essential experience certificate required for the post, if any.
- vii. Proficiency in computer application required for the post, if any.
- viii. Category certificate for those belonging to OBC-NCL, SC, ST, EWS, PWBD or Ex-Serviceman. The valid OBC-NCL certificate issued during the period from 01.04.2025 to last date of application i.e. 02.12.2025 will be considered. EWS certificate issued in prescribed format for employment in Central Government on the basis of income for the financial year 2024-2025 issued from 01.04.2025 but not later than 02.12.2025 will be considered.
- ix. Marriage certificate, if applicable.
- x. No Objection Certificate (NOC) from the Competent authority as applicable.
- xi. Original ID card for proof of identity issued by any government authority (Aadhar/Passport/Voter ID).
- xii. Address proof issued by any government authority (Electricity Bill, Ration Card, Voter Card, Passport, Aadhar etc).

6. Offer of appointments will be issued by AIIMS, Guwahati (physical/over email) to all the candidates whose document verification process would be done successfully. However, offer of appointment shall be purely provisional and subject to the outcome of various cases if any pending before Hon'ble Court/High Court etc.

7. AIIMS, Guwahati will not bear any expense related to the transportation or else while the candidates are arriving for document verification.

**Note:1. Criteria regarding caste/category certificates, age relaxation, etc. will be strictly adhered as mentioned in CRE advertisement Notice No. 355/2025, dated 11/11/2025 published by AIIMS, New Delhi in case of any anomaly.**
