- 1. - 4. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Bidder Guidelines for Physical Demonstration and Technical Data Shee ts

Introduction:

All participating bidders are required to adhere to the following guidelines for the procurement process at AIIMS, Guwahati. This document outlines the mandat ory physical demonstration and the submission of technical data sheets as part of the technical evaluation process.

1. Physical Demonstration:

1.1. Mandatory Requirement: Every bidder is obligated to arrange a physical de monstration of all the quoted items. This demonstration will take place at the sit e of AIIMS, Guwahati. The specific date and time for the demonstration will be c ommunicated to the bidders after the technical bid opening.

1.2. Importance of Physical Demonstration: The physical demonstration is an int egral component of the technical evaluation process. Bidders failing to organize the physical demonstration as per the provided schedule may risk the exclusion of their bid from further consideration.

2. Technical Data Sheets:

- 2.1. Submission During Physical Demonstration: All bidders must be prepared to provide technical data sheets of the products they have quoted during the physical demonstration. The technical committee of AIIMS, Guwahati, may request these data sheets during the demonstration.
- 2.2. Verification Process: The technical committee reserves the right to match a nd verify the information on the provided Data Sheets with the products demon strated during the physical demonstration. In the event of unexplained discrepa ncies in technical parameters, the bid may be subject to rejection.

3.Approval of sample before bulk production & supply

- 3.1.**Sample Submission:** The awardee of the contract is required to submit an d get approval of samples of each item (in exact technical specification, quality, standards, design, woven logo etc.) from the user department AIIMS, Guwahati before proceed for bulk production and supply of the items.
- 3.2.**Evaluation Process:** The AIIMS Guwahati User Department will conduct a t horough evaluation of the samples provided by the firm. This evaluation will foc us on ensuring that the samples meet the specified technical specification, qual ity, standards, design, woven logo etc. and any other requirements outlined in t he bidding documents.
- 3.3.Approval Notification: If the samples are found to be at a satisfactory lev el and comply with all specified requirements, the firm will be given clearance to arrange bulk supply of the linen.

Disclaimer/अस्वीकरण
