- b. All the experience gained shall be preferably from Government Organizations and shall be counted after the date of completion of Minimum Essential Qualification. Experience from reputed National/International Organizations shall also be considered.
- c. Experience shall be from the relevant field/area, as required for the study of the Project concerned.
- d. The candidate must be willing to undertake other responsibilities as may be assigned from time to time by the PI.

In this form candidates would need to upload scanned copies of Proof of Date of Birth, Essential and Desirable qualifications, No Objection Certificate (for government employees) etc. as specified above. Shortlisted candidates need to provide Original Certificates at the time of the interview for verification.
2. **This application form will expire five (05) days after the date of notification of this Call for Applications on the institute website. No applications will be considered after the form has been closed.**
3. Candidates will only be informed about their selection through the email address provided during submission of application. No separate information will be provided to candidates who have not been shortlisted.
4. Any misrepresentation or provision of wrong details by the candidates in their application will entail disqualification
5. Details of interviews/written tests shall be provided over email only to shortlisted candidates.
6. The decision of selection committee further to approval of Executive Director, AIIMS Guwahati will be final.
7. Details of selection will be communicated only to selected candidates and selection list will be published on AIIMS Guwahati website after the selection process is over.
8. **Selected candidates must be willing to join immediately upon selection.**

TERMS & CONDITIONS:

1. It is the candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfill essential eligibility criteria.
2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Guwahati.
3. Tenure: The assignments are purely on a contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Guwahati or for continued contractual appointment.
4. Expiry of Contract: The contract will automatically expire on completion of the period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. Accommodation: No hostel or any other accommodation will be provided by the Institute / Principal Investigator.
6. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of the interview.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any

- candidate for selection.
8. The candidate should bring along original certificates in support of his/her age, educational/professional qualification, experience etc., two recent passport size colour photographs. One set of self-attested photocopies of the relevant documents would need to be submitted at the time of interview/written test. Failing these, he/she will not be allowed to participate in the interview/written test.
 9. The candidate applying in response to this advertisement should satisfy themselves regarding their eligibility in all respects.
 10. No travelling or other allowances will be paid to the candidate for appearing in the interview/written test or for joining the post.
